RETURNING MEMBERS:

Monthly installments begin Jan 1, 2025 through September 1, 2025 for the 2025 season. The initiation fee will not apply for returning members who pay monthly for the 2025 season.

We will apply the 2024 rates for anyone who pays the membership in full by December 31, 2024. The initiation fee will not apply for returning members who pay in full by this date.

We are again offering the opportunity to pay your pool membership in two discounted, equal installments. The first installment is due January 1, 2025. The second installment is due by May 24, 2025.

If you cancel your membership by December 31, 2024 but decide later in the year to join the pool, you will have to pay a \$100 renewal fee for joining late in the payment season.

NEW MEMBERS:

An initiation fee of \$250.00 will apply to **ALL** new members.

Monthly payments start January 1, 2025 through September 1, 2025 for the 2025 season. You will have to pay any back payment from January 2025 to the month you start in one lump sum. Example: Joining March 2025 would require the \$250.00/initiation fee, plus January and February monthly installments to be paid upon joining, then the ongoing monthly installments would begin.
